NasCam Platform Regulations

TERMS AND CONDITIONS OF THE NasCam.cz WEBSITE

Valid for contracts concluded from November 16, 2020

I. GENERAL PROVISIONS

1. The owner of the nascam.cz website located at www.nascam.cz (hereinafter referred to as the Platform) and its administrator

2. The NasCam platform allows users to transmit and record video using an encoder, an appropriate IP camera, web camera and run multimedia files as VOD via streaming servers.
3. The User may run video transmissions and store video files on the Platform's servers.
4. Video transmissions published on the NasCam Platform are available only after logging in to it.
5. Using the services of the NasCam Platform is possible under the purchased ACCOUNT, referred to in the price list published on www.nascam.cz
6. For using the NasCam Platform, the user will be required to pay a monthly fee to the Administrator in accordance with the current price list published on www.nascam.cz. If the fee for using the Platform is not credited to the indicated bank account, the service will be suspended or disabled until the appropriate payment is made. The service is renewed within 24 hours. Using the NasCam platform does not require a contract. All you need to do is order and pay for the subscription. Posting the payment is simultaneous with granting access to the platform. The subscription extension consists in the purchase of additional packages in any number. After your payment is credited, it will be automatically updated on the NasCam platform.
7. By purchasing a subscription to the NasCam Platform, the user accepts the provisions of these regulations and undertakes to comply with them.

II. USING THE SERVICE

1. The account is activated by paying in the online store <https://shop.sell24.cz>. After the payment is correctly credited, the account in the panel is created automatically, the data is the same as when setting up an account in the online store. All payments are available in the online store after logging into your account.
2. Using the NasCam Platform requires access to the Internet and an installed web browser or appropriate software (encoder). Using the services of the NasCam Platform via an iPhone (iPod, iPad) and a mobile phone does not require installing any software on them, but only the use of appropriate Codecs.
3. The User undertakes to use the NasCam Platforms in a manner consistent with applicable law, the provisions of the Regulations and decency.

III. USER STATEMENTS

Recording materials on the NasCam Platform is tantamount to submitting a statement by the user that:

1. is the sole creator or contractor or producer of the materials and all its parts, or has the rights to the materials, or is entitled to dispose of, use or dispose of the materials published on the NasCam platforms,
2. the rights to the materials are not restricted to any third party,
3. materials and their use in accordance with the Regulations will not violate the rights, personal rights of other people, and the principles of social coexistence,
4. will secure the Administrator against claims of third parties that may arise in connection with the incorrectness of the above statements. In particular, the user shall immediately pay the awarded or agreed with the claimant the remuneration, compensation or redress, as well as remove the consequences of the breach and cover all related costs.

The user by publishing materials on the NasCam Platform on websites owned by us:

1. grants the Administrator a license to archive us.
2. acknowledges and confirms that the license and consent referred to in point 1 above are granted without any time, territorial or quantitative restrictions and without remuneration for the user and other entities authorized to the material.

The user agrees to:

1. receiving messages related to the NasCam Platform to your e-mail address.
2. The User is obliged to use the services of the NasCam Platform only using his account set up on this Platform. At the same time, he undertakes to protect his account passwords from disclosing it to other people.

The user may not:

1. conduct activities that may disrupt the functioning of the Platform or prevent the uninterrupted use of the Platform by other users,
2. violate proprietary copyrights and related rights to materials on the NasCam Platform,

3. violate the rights of third parties, in particular the rights to privacy, image protection, good name.

IV. ADMINISTRATOR'S RESPONSIBILITY

1. The Administrator is not responsible for any disruptions in the operation of the Website caused by force majeure, equipment failure or unauthorized interference by users, in particular if they would result in the loss of materials published on the Platform.
2. The Administrator is not responsible for the temporary inability to use the Platform resulting from maintenance, changes or improvements in its work. The Administrator will, if possible, inform the user in advance about technical breaks and their duration, in particular by posting messages on the Platform's pages.
3. In terms of the functionality of publishing materials, the Administrator only provides the service of maintaining data within the Platform provided by him. Subject to the provisions of the Regulations, the Administrator does not interfere with the materials published on the Platform. At the same time, the Administrator declares that he does not monitor the published materials or modify them.
4. As part of the Platform, the user may store materials in accordance with the disk space assigned to the selected account described in the price list published on the Platform's website. At the same time, the Administrator is not responsible for any distortions of the materials, their removal or difficulties in accessing the materials caused by external causes beyond the Administrator's control.
5. The Administrator reserves the right to introduce changes or modifications to the Platform.
6. In a situation where the publication of materials on the Website has been made in violation of the law, the rights of third parties, personal rights, good manners, principles of fair competition, secrets protected by law, the Administrator notified of such violation by an authorized person via e-mail to info [a] nascam.cz along with making the infringement more probable, it will take steps to block or remove the material that caused the violation.
7. In the event of objections to the functioning of the Platform, the user may submit a complaint via e-mail at the following address: info [a] nascam.cz. The administrator will provide a response to the complaint within 30 days, however, due to the circumstances of the case, this period may be extended. The administrator is not obliged to provide answers to obviously unjustified complaints, and also in a situation where, as a result of a justified complaint, he will make an appropriate correction in the functioning of the Platform. The Administrator declares that, within his technical, organizational or legal possibilities, he will make efforts to accept complaints, but is not obliged to take them into account.

V. BLOCKING THE MATERIAL AND THE USER ACCOUNT

1. The administrator has the right to block and remove material from the NasCam Platform. Before taking the actions referred to in this point, the Administrator will ask the user to remove the material on his own and to remove the resulting effects.
2. Blocking and / or deletion of the NasCam Platform user account will take place after the termination of the cooperation agreement. This may take place in the event of a breach by the user of the provisions of these Regulations.
3. The user's account will also be blocked in the event of using the NasCam Platform to conduct advertising or promotional activities to the extent not agreed with the owner of the NasCam Platform.
4. Any activities that may destabilize or interfere with the operation of the Platform, impede access to it or its content or its use by other users are prohibited. It is also forbidden to take any other actions that may cause adverse consequences for the Administrator, other users or third parties or actions that threaten their rights or interests.

VI. FINAL PROVISIONS

1. The current version of the Regulations is published at: www.nascam.cz
2. The Administrator reserves the right to make changes to the Regulations. The user will be informed in advance about each amendment to the Regulations by sending information about the changes to his e-mail address. If the changes to the Regulations are not accepted, the user may terminate the cooperation agreement.
3. In the case specified in point 2 above, the licenses and user consents granted in accordance with Chapter IV points 1-3 of the Regulations shall remain in force until the Administrator removes certain materials.
4. Using the NasCam Platform means the User's consent to the wording of the Regulations in force on the date of the cooperation agreement and, in the event of a change in the regulations in accordance with point 2, to any such change. In the event of non-acceptance of the Regulations or its change in accordance with point 2, the user or the Administrator may terminate the cooperation agreement.
